



BDVR-103 (12/2013)

By Authority of P.A. 300 of 1949, as amended; and P.A. 58 of 1995, as amended

Legislative Amendments

• PA 235 (SB 630 of 2017) – Effective January 1, 2018

Amends MCL 257.321a(2) which includes violations of section 703(1)(a) of the Michigan liquor control code (1st offense MIP) under the notice requirement for civil infraction suspensions.

PA 236 (SB 478 of 2017) – Effective January 1, 2018

Amends MCL 257. 321a which eliminates the susnset for 3 or more unpaid parking tickets.

PA 357 (SB332 of 2016) – Effective January 1, 2018

Amends MCL 436.1703 penalties for a minor in possession (MIP) violation.

- First violation is a state civil infraction with a maximum fine of \$100 one time only
- Second violation is a misdemeanor punishable by imprisonment for not more than 30 days, a maximum fine of \$200, or both
- Third violation is a misdemeanor punishable by imprisonment for not more than 60 days, a fine of not more than \$500, or both
- An individual can still have the second (or first misdemeanor offense) deferred

PA 358 (SB333 of 2016) – Effective January 1, 2018

Amends MCL 257.319 to define a "prior conviction" for purposes of a license suspension and indicates that it includes either a misdemeanor or a civil infraction determination.

- One prior conviction (either a state civil infraction or a misdemeanor) the license must be suspended for 90 days, a restricted license may be issued after 30 days
- Two or more prior convictions the license must be suspended for 1 year, a restricted license may be issued after 60 days

PA 448 (HB 4426 of 2016) – Effective January 5, 2018

Amends MCL 257.320 which allows the secretary of state to conduct a reexamination of a person who accumulates 6 or more one point violations within a 2 year period, as provided in MCL 257.320a(q).

Amends MCL 257.320a to modify the number of points assigned to a person's driving record for speeding.

- Speed exceeding by more than 10 mph but not more than 15mph will be assessed 3 points
- Speed exceeding by more than 5 mph but not more than 10 mph will be assessed 2 points
- Speed exceeding by more than 1 mph but not more than 5 mph will be assessed 1 point
- Speed in work zone exceeding 10 mph or less will be assessed 3 points

Legislative Amendments 2

PA153 (HB4548 2017) – Effective February 6, 2018

Amends MCL 257.625, 257.625a, 257.625g & 257. 625m which removed the scheduled sunset for .08 limit. The sunset was extended to October 1, 2021.

PA162 (SB436 2017) – Effective February 11, 2018

Amends MCL 257.304 certification of DWI/sobriety court by the state court administrative office; amends the vehicle code to reflect.

Beginning January 1, 2018, DWI/sobriety court includes only a DWI/sobriety court that is certified by the state court administrative office as provided in section 1084(3) of the revised judicature act of 1961, 1961 PA 236, MCL 600.1084.

Also adds (4)(b)(xi) to restrictions which states- At the discretion of the judge, the custodian of a minor child may drive to and from the facilities of a provider of day care services at which the custodian's minor child is enrolled, or an educational institution at which the custodian's minor child is enrolled as a student for the purposes of classes, academic meetings or conferences, and athletic or other extracurricular activities sanctioned by the educational institution in which the minor child is a participant. As used in this subparagraph, "minor child" means an individual who is less than 18 years of age.

SUBJECT: Public Acts 357 & 358 (2016) Minor in Possession (MIP)

Effective January 1, 2018, the Michigan Department of State will implement Public Act 357(2016) amending 436.1703 of the Michigan Liquor Control Code and Public Act 358 (2016) amending 257.319 of the Michigan Vehicle Code.

436.1703 provides a minor shall not purchase or attempt to purchase alcoholic liquor, consume or attempt to consume alcoholic liquor; possess or attempt to possess alcoholic liquor or have any bodily alcohol content. A first offense violation of 436.1703 (Minor in Possession-MIP) is responsible for a state civil infraction, zero points, no driver's license sanctions and shall not be fined more than \$100.00. A minor may be found responsible or admit responsibility to the Minor in Possession civil infraction only once. The civil infraction is reportable to MDOS using offense code 1360 and eligible for FCJ suspension.

If a violation of 436.1703 occurs after 1 prior judgement the minor is guilty of a misdemeanor. A 2^{nd} offense Minor in Possession conviction is zero points, suspension of the driver's license for 90 days, imprisonment of not more than 30 days, and/or a fine of not more than \$200.00. The MDOS may issue a restricted license after the first 30 days of license suspension.

If a violation of 436.1703 occurs after 2 or more prior judgements the minor is guilty of a misdemeanor. A 3rd or subsequent offense Minor in Possession conviction is zero points, suspension of the driver's license for 1 year, imprisonment of not more than 60 days, and/or a fine of not more than \$500.00. The MDOS may issue a restricted license after the first 60 days of license suspension.

The misdemeanor violations shall be reported to the Secretary of State using offense code 1360 and is eligible for FAC/FCJ suspension.

Page 2 2016 Public Acts 357 & 358 December 12, 2017

436.1703(3) provides an individual who pleads guilty to a misdemeanor violation or offers a plea of admission may be allowed one deferral for their guilty plea as a misdemeanor. The court shall abstract the plea and deferred sentence status using offense code 1360R to MDOS, who shall keep the record in non-public status, only viewable by law enforcement, courts and MDOS.

SUBJECT: 2016 Public Act 448 (HB 4423)

Effective January 5, 2018, the Michigan Department of State will implement Public Act 448 of 2016, amending 257.320 and 257.320a of the Motor Vehicle Code.

MCL 257.320a provides the number of points assigned to a person's driving record for civil infraction determinations. PA 448 amends the points assessed to the different speeding violations associated with offense code 2000. The point levels will be as follows:

- Speed exceeding by more than 1 mph but not more than 5 mph will be assessed 1 point
- Speed exceeding by more than 5 mph but not more than 10 mph will be assessed 2 points
- Speed exceeding by more than 10 mph but not more than 15 mph will be assessed 3 points
- Speed exceeding by more than 15 mph will be assessed 4 points

MCL 257.320 allows the secretary of state to conduct a reexamination of a person who accumulates a total of 12 or more points within a period of 2 years. PA 448 amends this section to also allow a reexamination to be conducted if a person accumulates 6 or more points from one-point speeding violations within a period of 2 years.

Subject: Michigan Department of State Preliminary Injunction

Pursuant to a preliminary injunction issued against the Michigan Department of State (MDOS), at this time MDOS is no longer allowed to suspend the driver's licenses of people unable to pay their traffic debt. Please see the MDOS memo.

MDOS is appealing this decision. In the interim, courts should still comply with the statutory mandates requiring courts to notify MDOS when a defendant has failed to appear or comply with a judgment. MCL 257.321a.

If a defendant contests his ability to pay a court-ordered financial obligation, the determination of ability to pay is a judicial determination. Courts may set the matter for a hearing on the ability-to-pay issue and render a decision. The ability-to-pay assessment is necessary when the imposition of a court-ordered financial obligation is enforced and the defendant contests his ability to pay. See *People v Jackson*, 483 Mich 271 (2009).

If the court determines the defendant does not have the ability to pay and the defendant's license is suspended, MDOS requests that the court notify MDOS to clear the suspension. SUBJECT: PA 162 (SB 436 -2017) Sobriety Court Restricted License Amendment

Effective February 11, 2018, PA162 (SB 436 -2017) amends MCL 257.304 certification of DWI/Sobriety Court by the State Court Administrative Office; amends the vehicle code to reflect:

Also adds (4)(b)(xi) to restrictions which states- At the discretion of the judge, the custodian of a minor child may drive to and from the facilities of a provider of day care services at which the custodian's minor child is enrolled, or an educational institution at which the custodian's minor child is enrolled as a student for the purposes of classes, academic meetings or conferences, and athletic or other extracurricular activities sanctioned by the educational institution in which the minor child is a participant. As used in this subparagraph, "minor child" means an individual who is less than 18 years of age.

The Michigan Department of State is currently working with the State Court Administrative Office to update the MC-393 form to reflect the option of adding this restriction. Until the form can become amended, the MDOS will <u>only</u> accept a court order including the participant's name, driver license number and date of birth. This amended provision applies to current and future Sobriety Court participants.

SUBJECT: 2018 Public Acts 43, 44, 45, 46, 48 and 50

(HB 5040, 5041, 5043, 5046, 5079)

Effective immediately, the Michigan Department of State will implement Public Acts 43, 44, 45, 46, 48 and 50 of 2018, amending 257.732a, 257.732b, and 257.304 of the Motor Vehicle Code; also added 257.732d of the Motor Vehicle Code. The Driver Responsibility Fee (DRF) program changes are as follows:

- Beginning Oct. 1, 2018, Michigan's Driver Responsibility Fee Law will no longer be in effect, meaning no new DRF assessments and outstanding DRF fees will not be collected.
- Beginning March 30, 2018 the Department of Treasury will implement a workforce training program and offer it as an alternative to payment of certain assessed DRF.
- Any outstanding DRF shall not be collected from individuals who have entered into a payment plan
 and were in good standing on or before February 1, 2018. Those individuals will have no liability for
 outstanding fees or the standard reinstatement fee.
- Payment of a reinstatement fee is waived through December 31, 2018.
- Effective September 30, 2018, any outstanding DRF will not be collected. An individual whose driving privileges were suspended for non-payment of DRF will be eligible to reinstate their driver license if there is no other licensing sanction.
- Beginning January 1, 2019 individuals with a DRF suspension must pay the reinstatement fee.
- DRF fees will be waived for an individual who successfully participated in a DWI or sobriety court program that ends on or after October 1, 2018.

ELIMINATING Driver Responsibility Fees

The Driver Responsibility Law took effect October 1, 2003. There have been several amendments to this law. The most recent amendments ELIMINATE the Driver Responsibility Fee Law on October 1, 2018.

MARCH 31

Effective March 31, 2018, individuals who entered into a payment plan on or before February 1, 2018 will have their outstanding Driver Responsibility Fees eliminated. If there are no additional license actions pending, you may be eligible to reinstate your driver's license without paying a reinstatement fee* beginning March 31.

OCTOBER 1

Individuals who did not enter into a payment plan on or before February 1,2018 are still responsible for making payments until October 1,2018. All Driver Responsibility Fees and reinstatement fees* associated with Driver Responsibility Fees will be waived at this time.



Please contact the Michigan Department of Treasury, I-800-950-6227, for payment plan options. Once entered into a payment plan, individuals that have no additional license actions pending may be eligible to reinstate their driver's license without paying a reinstatement fee*, March 31 through December 31, 2018. Some unemployed individuals may qualify for participation in a Workforce Development Program in lieu of payment. Please check the website below for details.

^{*} Reinstatement fees will be waived through December 31, 2018. Beginning January 1, 2019, they will be required. If your license is currently suspended for other violations, such as failure to appear in court or driving on a suspended license, among others, you must clear these before reinstating.

Frequently Asked Questions Regarding ELIMINATING the Driver Responsibility Fee (DRF)

Has the Driver Responsibility Fee law really been eliminated?

Yes, as of October I, 2018 the Michigan Driver Responsibility Fee Law will no longer be in effect and the Michigan Department of Treasury will cease collection activity.

If I am unemployed and unable to make my DRF payments, how can I reinstate my driver's license?

Beginning March 31, 2018, a Work Force Development program will be available for qualified individuals. If you complete one of the qualifying programs, your Driver Responsibility Fees will be waived. A list of qualifying Work Force Development programs and participating agencies will be available by March 31. Please continue to check www.Michigan.gov/driverresponsibility for updates.

How do I apply for the Work Force Development program?

Beginning March 31, 2018, information about qualifying Work Force Development programs and participating agencies will be available at www.Michigan.gov/driverresponsibility.

Will I receive a refund for Driver Responsibility Fees I have paid?

No refunds will be issued. Neither the current nor the new Driver Responsibility Fee laws provide legal authority to issue refunds under any circumstances.

When can I get my license reinstated?

If your payment plan/installment agreement began on or before February I, 2018, and if you have not already reinstated your license you may do so between March 31, 2018 and December 31, 2018 without a reinstatement fee. Beginning January I, 2019 a reinstatement fee will be required.

Please note: If your license is suspended for other violations, such as a failure to appear in court or driving on a suspended license, among others, you must clear these before reinstating.

Is there anything I have to do to have my Driver Responsibility fee waived?

No. The Michigan Department of Treasury and Michigan Secretary of State's Office will work together to eliminate your Driver Responsibility Fee and cease all collection activity.

Can I be issued any additional Driver Responsibility Fees?

The law prohibits the assessment of Driver Responsibility Fees beginning October 1, 2018. Until that time new fees can still be assessed for qualifying convictions.

Will I be assessed a second-year fee?

No. These fees were eliminated effective October 1, 2016.

I was on a payment plan on or before February I, 2018. Should I stop paying?

The balance of your payments will be waived and you will owe nothing more after March 31, 2018. No additional payments are necessary.

I have already paid my reinstatement fee. Is there anything I need to do?

No, your Driver Responsibility Fee will be eliminated.

My payment plan included the reinstatement fee. Is there anything I need to do?

No, effective March 31, 2018 your Driver Responsibility Fee will be eliminated and your reinstatement fee will be waived.

If there are no other pending license actions you will be eligible to apply for license reinstatement.

When can I get my license reinstated?

Individuals whose license is suspended as a result of a Driver Responsibility Fee can set up an installment agreement now and get their license back. Reinstatement fees will not be charged between March 31, 2018 and December 31, 2018. The installment agreement will be in effect until October 1, 2018. At that time the balance will be waived.

Please note: If your license is suspended for other violations, such as a failure to appear in court or driving on a suspended license, among others, you must clear these before reinstating.

Is there anything I have to do to have my Driver Responsibility fee waived?

No. The Michigan Department of Treasury and Michigan Secretary of State's Office will work together to eliminate your Driver Responsibility Fee and cease all collection activity.

Can I be issued any additional Driver Responsibility Fees?

The law prohibits the assessment of Driver Responsibility Fees beginning October 1, 2018. Until that time new fees can still be assessed for qualifying convictions.

Will I be assessed a second-year fee?

No. These fees were eliminated effective October 1, 2016.

I was not on a payment plan on or before February I, 2018. Am I responsible for paying? Why should I pay?

You are still responsible for making payments until October 1, 2018. Please contact the Michigan Department of Treasury, 800-950-6227, for payment plan options.

If you enter into a payment plan and remain current on your payments you may be eligible to have your driver's license reinstated and the reinstatement fee will be waived between March 31, and December 31, 2018.

Failure to make payments may result in further actions against your driver's license.

Please note: If your license is suspended for other violations, such as a failure to appear in court or driving on a suspended license, among others, you must clear these before reinstating.
