Legislation of Interest by Tom Bleau. President. MADCM.

PA 1 of 2005, creates a civil infraction with \$10.00 fine for selling goods on a public right of way without a license.

SB 311-312 requires insurance companies to notify SOS of expiration or termination of car insurance. Requires SOS to create registry of insured drivers.

SB 313-314 requires all passengers under 16 to be seat belted. (Change from current law which exempts minors if more minors than seatbelts)

SB 345 creates civil infraction for leaving a vehicle unattended with engine running

SB 297 motorcycle no helmet law - passed Senate

HB 4160 increases small claims limit to \$10,000. This is unanimously opposed by vote of Judicial Conference Executive Committee of State Bar on 2/18/05.

Driver Responsibility Update,

As of May 31, there were 336,287 assessments sent to Treasury totally \$127,533,600. Treasury has actually collected \$43,372,512.11 (or 34.0%). DR suspensions for approximately 250,000 drivers will be mailed beginning October 1, 2005.

Abandoned Vehicle Summary,

Effective October 1, 2005, law enforcement and towing agencies will partner with the Michigan Department of State (MDOS) to expedite the abandoned vehicle removal and notification process. The process will look something like this:

If the vehicle is abandoned on public property (18-48 hours), law enforcement or their designee may tag the vehicle for removal and/or

arrange for a tow. If the vehicle is abandoned on private property, the property owner may arrange for immediate removal of the vehicle.

Once a vehicle is towed and taken into custody, law enforcement conducts a stolen vehicle check and within 24 hours notifies MDOS via LEIN that a vehicle has been abandoned.

Within 7 days, MDOS will make information available on the new abandoned vehicle website and send a notice and court petition to the last titled owner and a notice to any secured party on record that their vehicle has bene reported abandoned. A pre-printed Bill of Sale/Ownership Transfer (TR-52) document will be sent to law enforcement.

The owner has 20 days from the date on the notice to redeem the vehicle or file an appeal. If the vehicle is not redeemed and there is no appeal within 20 days, law enforcement (if abandoned on public property) or the custodian (if abandoned on private property) may offer the vehicle for sale at a public auction.

If the vehicle is redeemed or sold at auction, the custodian and law enforcement will notify MDOS of the disposition. MDOS will update the new abandoned vehicle website and process an EFT from the custodian in the amount of \$25.00 (new abandoned vehicle fee \$40.00, the remaining \$15.00 goes to the tower).

If the vehicle has been deemed scrap or ownership of the vehicle is transferred to the custodian to cover their costs, the disposition will be reported, updated to the website and no fee will be collected.

In addition to establishing an abandoned vehicle website and notifying vehicle owners, MDOS will modify title documents on the proper vehicle ownership transfer process and insert
