Hi Mary,

We waive all fines and costs if Defendant brings their license to the Court and it was valid at the time of the stop. They do not need to show it to law enforcement.

We no longer accept these tickets as direct filed as we have our prosecutor's office authorize them first.

Our officers usually do not give an appearance date/time, they usually give them 3-14 days to answer to the charge.
