If the Magistrate is not authorized to take the plea, it is not done in this court. The defendant is arraigned and I enter a plea of "not guilty." When I know that the Judges cannot see the defendant, I do not give the defendant an opportunity to enter a plea of guilty. I rarely explain lack of authority under statute as the reason. (I am certain ego has something to do with it.) Instead I tell the defendant that for the court to be assured that a "knowing and voluntary" plea is offered a pretrial meeting with the assistant prosecutor is appropriate. I further advise the defendant that in going to the prosecutor none of the rights have been waived.

As always, "check with your chief judge."
