I would check with your chief judge. Some may view it as compelling a defendant to testify against himself, while others may see it as providing non-testimonial evidence. For instance, there was a recent case which distinguished between requiring a defendant to give up his passcode to his smart phone, which was seen as compelling testimony, from requiring him to place his thumb on it to open it, which was seen as non-testimonial. While I would agree authorizing search and seizure of writings already in existence would be allowed, requiring a defendant to provide new ones would not be.

A handwriting sample is an identifying physical characteristic outside the protection of the Fifth Amendment. If the content of the exemplar is not testimonial or communicative matter, it will not be protected.
