I agree with Pat on Number two as well. A city case and state case cannot be on the same complaint number. What suffix would you use to label it OM or SM etc...?

So the city case must be sworn out by a city officer and the state case would be sworn out be a state of sheriff officer with two separate files. The defendant can be arraigned on both at the same time, but then you list the two different case numbers.

As to #2, my city attorney only has authority over city cases while the county prosecutor issues under state law. A complaint and warrant can't mix and match. If both charges are state, they can be combined in a single file. This is most common when I see a felony and a misdemeanor on a single warrant/ complaint. But if one is state and one is city, I have two files. Hope this helps

the outstanding complaint and warrant. To issue the warrant how would you process? Would you have both officers give their probable cause and issue to the department that is listed on the complaint and would they both need to be present at the same time?
